BOARD OF COMMISSIONERS

APRIL 21, 2020

(1) The Board of Commissioners, in and for the County of Scott, Minnesota, met in the Courthouse Board Room in the City of Shakopee, Minnesota, and convened at 9:00 a.m., with the following members present: Commissioner Beer, presiding, Commissioner Weckman Brekke, Commissioner Wolf, and Commissioner Beard. Commissioner Ulrich participated via phone. Chair Beer announced all votes will be by roll call vote.

(4) Minutes:

On a motion by Commissioner Weckman Brekke, seconded by Commissioner Wolf, the Minutes of April 7, 2020 were approved on a roll call vote.

(5) Recognition of Interested Citizens:

John Myser spoke of his perception of elected officials' duties and the legalities of suspending a driver's license. He also requested a copy of the County's liability policy as it pertains to torts.

(6) Consent Agenda:

- A. On the recommendation of the Credit River Town Board and the Planning Advisory Commission, Commissioner Wolf moved, seconded by Commissioner Weckman Brekke to approve the request for final plat of Crescent Curve (Crescent Curve, LLC applicant and property owner) consisting of 23 lots on 85.89 acres in Sections 27 and 34 of Credit River Township and Three-Way (Developer, Township, and County) Development Agreement. The motion carried unanimously on a roll call vote.
- B. On the recommendation of the Credit River Town Board and the Planning Advisory Commission, Commissioner Wolf moved, seconded by Commissioner Weckman Brekke to approve the Conservation Easements of Maggie Lane Farm (Clarence Van Zee, applicant and Van Zee Living Trust, property owner) a subdivision consisting of 3 lots of 51.33 acres in Section 27 of Credit River Township. The motion carried unanimously on a roll call vote.

- C. Commissioner Wolf moved, seconded by Commissioner Weckman Brekke to approve the purchase of two laptop-based 800 MHz radio consoles for continuity of operations. The motion carried unanimously on a roll call vote.
- D. On the recommendation of the County Administrator, Commissioner Wolf moved, seconded by Commissioner Weckman Brekke to approve the payroll processing of personnel actions indicated below and certified by the Employee Relations Director and the Appointing Authority to be in compliance with provisions of Minnesota Statutes 375.56 375.71 and the Scott County Merit Personnel System:

Commissioner Wolf moved, seconded by Commissioner Weckman Brekke to adopt Resolution No. 2020-072; Authorizing the Submittal and Acceptance of the Minnesota Trail Assistance Grant Program Application for Scott County Sno-Trials, Inc. for the 2020-2021 Snow Season. Commissioner Wolf moved, seconded by Commissioner Weckman Brekke to adopt Resolution No. 2020-074; Approving Entering Into an Agreement With the Minnesota Pollution Control Agency for the 2020 Local Recycling Development Grant. Commissioner Wolf moved, seconded by Commissioner Weckman Brekke to adopt Resolution No. 2020-073; Approving the Findings of Fact and Conclusions for the Jordan Interchange Environmental Assessment Worksheet and Negative Declaration on the Need for an Environment Impact Statement. - I. Commissioner Wolf moved, seconded by Commissioner Weckman Brekke to adopt Resolution No. 2020-076; Awarding a Contract to Asphalt Surface Technologies Corp. for the 2020 County Sealcoat Project. Commissioner Wolf moved, seconded by Commissioner Weckman Brekke to adopt Resolution No. 2020-077; Awarding a Construction Contract to MP Asphalt Maintenance Inc. for the 2020 Trail Sealcoat Project. It was reported the Scott County Emergency Operations Center has been scaled down and is currently operating in a monitoring capacity.

The Commissioners requested that as much context as possible be given and common language be used when presenting COVID-19 data.

(8) Stewardship: We will work proactively to make investments, guided by resident input, which will transform lives, communities, and government:

County Engineer Tony Winiecki presented a request to amend the 2020-2029 Transportation Improvement Program (TIP) to add County Project 21-36 to install a traffic signal system at the County Highway (CH) 21/CH 92 intersection. Mr. Winiecki reported County Highway Department staff has been monitoring the CH 21/CH 91 intersection and reviewing various long-term solutions to address operations and safety. It was demonstrated that this intersection meets warrants for signalization. Due to the extended lead time for manufacturing and delivery and to expedite the installation, staff is requesting to pre-purchase the traffic signal hardware and control equipment to furnish to the construction contractor. This process has been used on previous projects.

Commissioner Wolf moved, seconded by Commissioner Beard to adopt Resolution No. 2020-075; Approving an Amendment to the 2020-2029 Transportation Improvement Program to Add County Project 21-36 to Install a Traffic Signal System at the County Highway 21/County Highway 91 Intersection. A copy of the resolution is available in the office of the County Administrator and is made a part of this record by reference. The motion carried unanimously on a roll call vote.
